- **Running on a Stand-Alone Computer**—It is possible to run Amicus Attorney in a single user environment. Requirements are the same as a Workstation with Offline except that SQL Server 2005 Workgroup or Standard Edition is required.
- **Other Applications**—The requirements in this document are for running Amicus Attorney. If running additional applications at the same time, ensure that the computer has sufficient resources for those other applications as well.
- **Firewalls**—Ensure that Amicus Attorney (and SQL Server or SQL Server Express, as applicable) are not blocked at the Application Server and Offline Workstations.
- **System Check**—When installing Amicus Server or Workstation Offline components, the Installer will perform a System Check to ensure that your machine meets requirements.
- **Terminal Server Network**—Amicus Attorney can be used in a terminal server environment. The terminal server needs a very fast processor. Required for *each terminal user*: a minimum of 256 MB RAM (512 MB recommended).
- **Novell Network**—A Novell Netware File Server can be used for storing shared documents, backups, etc. but the Amicus applications must be installed under Windows.
- **Offline Components**—Offline Components cannot be installed on your Amicus Attorney Application Server.
- **Service Packs**—The latest Service Packs for Windows, SQL Server, and Internet Explorer are required.

Database Software

- **Microsoft SQL Server**—The following SQL Server 2005 Editions can be used to host your Amicus Server Database: Workgroup, Standard, and Enterprise. Note that neither SQL Server 2005 Express Edition nor 64-bit Editions are supported for use as your main Amicus database. (However, Express Edition is used to host the user's Amicus Offline database, and will be automatically installed on the Amicus Workstation during Offline configuration.)
- The Amicus database may reside on a different computer from the Amicus Application Server—this is called a *split install*. These servers must reside in the same subnet and domain.
- **Ensure that the latest Service Packs are installed.**
